This is reflected not only in its direct contributions to the creative and cultural industries, which account for 3% of the global GDP, but also in its broader economic benefits. Additionally, culture plays a vital role in social development by providing extensive employment opportunities, fostering diversity and cross-cultural understanding, preserving cultural identity, and enhancing social participation.

# Measuring the impact of culture is a complex task. The key challenges facing efforts in this regard include:

- 1. The indirect impact of culture: Culture influences development in indirect ways, making it difficult to measure its impact. For example, culture can contribute to reducing crime rates and strengthening social cohesion, but these effects may not be immediately visible or easily quantifiable. Additionally, the economic returns of cultural industries are often long-term and cannot be measured immediately.
- 2. Lack unified measurement indicators: One of the biggest challenges in assessing the impact of culture on development is the absence of standardized measurement indicators that can be applied across different Islamic countries. For instance, while some countries rely on economic indicators such as the contribution of cultural industries to GDP, others focus on social indicators like cultural participation and its effect on social cohesion. This variation makes it difficult to compare data and identify general trends.

- 3. Shortage of accurate data and statistics: Many Islamic countries lack reliable data and statistics on the economic and social impact of culture. This is due to the limited number of field studies, inadequate allocation of resources for collecting data on cultural industries, community participation in cultural activities, and the overall impact of culture on the quality of life.
- 4. Technological and Digital Challenges:
  In the era of digital transformation,
  measuring the impact of culture requires
  advanced technologies such as artificial
  intelligence and big data analysis.
  However, some Islamic countries
  face challenges in adopting these
  technologies due to underdeveloped
  digital infrastructure and a shortage of
  technical expertise.

### Recommendations for enhancing the measurement of culture's impact on development

- 1. Developing unified indicators for measuring cultural impact: Establishing standardized measurement indicators that take into account the cultural specificities of Islamic countries. This can be achieved by drawing on global experiences, such as UNESCO's indicators and the United Nations' sustainable development indicators.
- 2. Enhancing data collection and cultural statistics: Allocating more resources for collecting and analyzing data related to culture and development. This can be achieved by creating specialized research centers and strengthening collaboration with international organizations.
- 3. Leveraging technology for cultural evaluation: Employing modern technologies such as artificial intelligence and big data analysis to assess the impact of culture more accurately, particularly

- in areas such as creative industries and cultural participation.
- 4. Supportingresearchontherelationship between culture and development:

  Encouraging more academic and field research that explores the link between culture and development, providing practical evidence to support policymakers.
- 5. Integrating culture into development plans: To effectively measure culture's impact, it must be incorporated into national sustainable development plans and promoted across various sectors, including education, tourism, and creative industries.
- 6. Engaging local communities and stakeholders in cultural policy development: Cultural policies that empower community growth and activities foster sustainable development, as they do not require heavy institutional support or direct supervision.

#### Conclusion

Amid the challenges facing the Islamic world, it is crucial to strengthen integrated cultural policies that support sustainable development while balancing heritage preservation with future aspirations. Culture can become a key driver of economic growth and social cohesion in the Islamic world, through clear strategies and sustainable investments,
